- You have worked a minimum of five years during the 10 years preceding your disability and you have paid taxes on your earnings during this time;
- You have become unable to work before you reach your full retirement age, which could be 65 or older, depending on your birth date.

"Many valid claims for [Social Security Disability](#) are denied because of flaws in the application process," Schwartzapfel said.
